### **Fall Explanations:**

For Advanced Novice Singles and Pairs, the deduction for a fall is 0.5.  
There will be no deduction for a fall after a fully rotated 2 A or triple jump.

## Seniors

**Age Requirements:** In accordance to ISU Constitution and General Regulations 2010, Rule 108.2.b

## Senior Ice Dance

### **Short Dance:**

Duration: 2.50 min +/- 10 sec

In accordance to ISU Special Regulations & Technical Rules Ice Dance 2010 Rule 609 and all pertinent ISU Communications

In the season 2011/2012 the composition of the Short Dance will contain 5 Required Elements in total:

One to three of the following Latin American Rhythms: Cha Cha, Rhumba, Samba, Mambo, Merengue.

Two sequences of Rhumba, either skated one after the other or not skated one after the other.

The pattern Dance Elements can be skated to any of the above mentioned Rhythms (both elements to the same Rhythm or one element to one Rhythm and the second element to a different Rhythm), in the style of this Rhythm(s), with the following range of tempo: 43 to 45 measures of four beats per minute (172-180 beats per minute). The tempo of the music throughout the Pattern Dance Elements must be constant.

3 Required Elements in the Creative Dance Part (Short Lift, Not Touching Circular Step Sequence and Set of sequential Twizzles).

The music of the entire Short Dance (including music for specified Pattern Dance) is provided by the couple and may be vocal.

### **Free Dance:**

Duration: 4 min +/- 10 sec

In accordance to ISU Special Regulations & Technical Rules Ice Dance 2010 Rule 610 and all pertinent ISU Communications

#### **Well Balanced Program and Required Elements:**

ISU Technical Rules Ice Dancing 2010, Rule 610 paragraph 2 and the respective ISU Communication must be observed.

## **Junior Ice Dance**

**Short Dance:** Duration: 2.50 min +/- 10 sec

In accordance to ISU Special Regulations & Technical Rules Ice Dance 2010 Rule 609 and all pertinent ISU Communications

In the season 2011/2012 the composition of the Short Dance will contain 5 Required Elements in total:

2 Required Elements in the Pattern Dance Part:  
2 sequences of the Cha Cha Congelado performed one after the other.

3 Required Elements in the Creative Part (Short Lift, Not Touching Midline Step Sequence and Set of Sequential Twizzles)

The music of entire Short Dance (including music for specified Pattern dance) is provided by the couple and may be vocal.

The Pattern Dance Elements must be skated on the Cha Cha Rhythm, in the style of the Cha Cha, with the following range of tempo: 28 to 30 measures of four beats per minute (112-120 beats per minute). The tempo of music throughout the Pattern Dance Elements must be constant.

Two full sequences of the dance must be performed one after the other.

**Free Dance:** Duration: 3 ½ min +/- 10 sec

In accordance with ISU Special Regulations & Technical Rules Ice Dance 2010 Rule 610 and all pertinent ISU Communications.

### **Well Balanced Program and Required Elements:**

ISU Technical Rules Ice Dance 2010, Rule 610.2 and the relevant ISU Communication must be observed.

## **Advanced Novice Ice Dance**

**Pattern Dance:** In accordance with ISU Communication No. 1649  
**Guidelines for International Novice Competitions**

**2 Pattern Dances are to be skated.**

In the season 2011/2012 **1 Pattern Dance** shall be drawn from each group before the first official practice.

Group 1: **#4 European Waltz** **#20 Tango**

Group 2: **#3 Rocker Foxtrott** **#9 Starlight Waltz**

Duration: 3 min +/- 10 sec

### **Music**

All Competitors shall furnish competition music of excellent quality on CD, MD or DAT format. In accordance with Rule 343 all cassettes and discs must show the Competition event, the Competitors name, the Members name and the exact running time of the Music (not skating time) including any starting signal, and must be submitted at the time of registration.

### **Planned Program Sheet**

Attached "Planned Program Sheets" have to be filled in precisely and must return together with the entry forms to the Organizing Committee in time.

### **Accreditation**

The official accreditation is at the main entrance of the Ice Rink. Accreditation will be given to Competitors, Judges and Coaches.

### **Results**

The determination and publication of the results will be done according to ISU Technical Rules for Single & Pair Skating and Ice Dance 2010, Rule 352 and 353.

### **Awards**

The first three best placed competitors and couples in each event will be awarded by Medals or Trophies, there will be Diplomas for all participants. The Award Ceremonies will be published with the official Time-Schedule.

### **Exhibition**

The first three best placed skaters and couples in each event will be requested to skate at the closing exhibition on Sunday February 5. Show programs are welcome.

### **Liability**

In accordance with Rule 119, it is the sole responsibility of each Member participating in the Bavarian Open Figure Skating and Ice Dance 2012, to provide medical and accident insurance for their athletes, officials and all other members of the Member's team. Such insurance must assure full medical attendance and also the return to the home country by air transport or by other expeditious means of the ill or injured person.

The Organizer assumes no responsibility for or liability with respect to bodily or personal injury or property damage incurred in connection incurred by Competitors and Officials.
